The biggest judicial scandal ever seen in Germany

In September 2024, Malone News published an article on Dr. Reiner Fuellmich, titled “**The Persecution of Dr. Reiner Fuellmich, A POLITICAL PRISONER.**” German authorities continue to illegally imprison Dr. Fuellmich. This is an update.

Dr. Reiner Fuellmich is known and respected internationally for his work as a consumer defense lawyer and for winning major lawsuits against corporate giants such as Volkswagen, Kühne & Nagel, and Deutsche Bank. He was one of the first individuals to recognize that the COVID measures constituted crimes against humanity and decided, along with three other lawyers, to create the Corona Investigative Committee, which aimed to shed light on the actions of governments, public institutions, and the medical community in the context of the so-called “pandemic.”

Thanks to his brilliant investigative work, and after consulting more than 150 scientists and experts in all fields around the world, as well as numerous whistleblowers (from Pfizer, WHO, CDC, UN), he was able to collect an abundance of evidence of what he calls “the biggest crime ever perpetrated against humanity.”

He was ready to take action.

However, the German secret services, in cooperation with Göttingen public prosecutor Simon Phillip John and Fuellmich’s accusers, had already decided to construct a case against Fuellmich, aimed at stopping him.

He is accused of having embezzled 700,000 euros, but, in truth, he did not. The imminent threat of seizure of the Corona Investigative Committee’s bank accounts by the German government during the fallout of the COVID pandemic, along with the risk of no longer being able to use the funds raised by private donations to carry out their investigative work, Reiner Fuellmich and Viviane Fischer took steps to protect those funds. They purchased 1 million euros worth of gold (current value: 1.8 million euros), and each took out personal loans (700.000 euros to Reiner Fuellmich, and 100.000 euros to Viviane Fischer). Their loan agreements were documented in written, signed contracts.

When the defense demonstrated the erroneousness of the original accusation which asserted that Fuellmich had no authority to take a personal loan without the other committee member’s consent, the judge had to invent a new allegation in order to justify Fuellmich’s continued imprisonment. The judge thus declared that the loans were “fake”.

Interestingly, the previous Göttingen lead prosecutor Reinicke, who had been asked by the secret services to open an investigation on Fuellmich, had clearly stated that there were no grounds upon which to investigate him and archived the case in June 2022. Merely two and a half months later, a young, inexperienced prosecutor by the name of Simon Phillip John was transferred from Hanover to Göttingen and given the task of doing the dirty work that Reinicke had previously deemed unjustified.

Judge Carsten Schindler and prosecutor John are, without any shadow of a doubt, following someone else’s instructions. Dr. Reiner Fuellmich has been unlawfully held in pre-trial detention in the German maximum-security prison in Rosdorf for 18 months. This, even though the maximum term for pre-trial detention in Germany is 6 months. This, after his having been lured under false pretenses, subsequently abducted in Mexico, and then deported to Germany –without an

international arrest warrant NOR a formal extradition order-- where he was then arrested and imprisoned.

The circumstances of his illegal arrest and subsequent mistreatment in prison are very concerning.

From June 2024 until December 2024, Reiner Fuellmich was placed in solitary confinement. The official reason was that he was providing fellow inmates with legal advice. Fuellmich was also subjected to various forms of abuse, in clear violation of his human rights: physical and psychological mistreatment including prolonged solitary confinement, deprived of sunlight, deprived of outdoor physical activity, deprived of sleep, forced to choose between taking a shower or having his one-hour outdoors, and even prohibited from calling his lawyers. **Aside from their brief (and monitored) telephone calls on Skype, he has not seen his wife since his arrest.**

He is only permitted three hours per month of visits and telephone calls. On top of that, he has been denied adequate medical care, including simple access to vitamins.

Moreover, Reiner was not allowed to visit his dying mother, nor attend her funeral.

Both the inhumane prison conditions and how his trial is being conducted raise serious doubts about the level of respect for fundamental rights in the German judicial system.

From June 10, 2024 to this day, Reiner Fuellmich, after being body-searched, is brought to the court and back to prison in shackles and handcuffs, escorted by armed security officers in armored vehicles, as if he were a serial killer!

He is being denied a fair trial because any motions presented by his defense lawyers are rejected without explanation. As of July 2024, Judge Schindler ordered that the defense motions and arguments, instead of being read aloud to the court, were from then on to be presented in writing only, thus impeding court observers from understanding and properly documenting the proceedings. These same court spectators, as have Fuellmich's defense lawyers, have been subject to threats.

In addition to not permitting defense witnesses to take the stand, Judge Schindler refuses to allow the person who pocketed the funds to testify in court.

This "kangaroo court" proceeding is now in its final phase. As we write this, the defense lawyers have completed their closing statements, and Fuellmich has begun to make his final, closing statement before the court, which, to silence him, interrupted and admonished him at least 12 times.

It is feared that the court may impose upon Fuellmich a time limit for the presentation of his final defense statement, as they did to his defense lawyers, forcing them to shorten their closing statements.

In the course of 51 hearings, what we have witnessed is nothing less than an egregious case of obstruction of justice-- a criminal offense in Germany-- which confirms the intent of the German secret services as stated in their dossier on Reiner Fuellmich.

One of Fuellmich's defense lawyers presented this dossier to the court. It specified that Fuellmich was to be stopped “at all costs”; that “it is necessary to prepare a criminal case against Fuellmich, [including the] collaboration of prosecutors and suitable third parties”; and recommending “the recruitment and involvement of trusted persons amongst Fuellmich’s closest circle.”

It was also their stated objective to convict Fuellmich; that “the possibility of [him] obtaining a politically exposed position must be prevented by any means”. This dossier, provided by a whistleblower, demonstrates that Reiner Fuellmich was already under special surveillance as far back as 2021.

That said, it is beyond a shadow of a doubt that Reiner Fuellmich had to be stopped to prevent him from continuing his precious investigational work exposing the truth regarding the “pandemic” as well as the so-called “vaccines”.

Fuellmich is clearly a political prisoner, punished for speaking the truth. His case demands the attention of international human rights organizations and the indignation of worldwide public opinion.

Pre-trial detention must never be used as an instrument to defer, suppress, or completely substitute the justice system as a legitimized punishment without a sentence.

Justice, free speech, and respect for fundamental human rights are the pillars of a democratic state, not only for but especially for those individuals who raise uncomfortable questions and dare to speak up.

In an interview with *Radio München* Professor Dr. Stefan Hockertz criticised the mass vaccination scheme apparently planned by the German government. He describes it as intentional bodily harm. Professor **Dr. Stefan Hockertz** is an immunologist and toxicologist. He is managing partner of *Tpi Consult GmbH*, one of Europe's leading toxicological and pharmacological technology consultancies. Dr. Stefan Hockertz was director and professor at the **Institute of Experimental and Clinical Toxicology at the University Medical Center Hamburg Eppendorf** from 2003 until the end of 2004. Prior to that, he was a member of the board of the **Fraunhofer Institute for Toxicology and Environmental Medicine** in Hamburg from 1995 to 2002. From 1986 to 2001 he was a research fellow at the **Fraunhofer Society** in Hannover. Hockertz completed his first training as a biologist in 1985. He is also Dr. rer. nat. in biology at the University of Hannover, qualified as professor of toxicology and pharmacology at the University of Hamburg, and professor of

molecular immunotoxicology at the University Medical Center Hamburg Eppendorf.

In the *Radio München* interview Hockertz also talks about the concrete effects of mass vaccination against the coronavirus on the population of Germany, with more than 80 million people. This could be extrapolated to the population of other countries.

«The video of the interview with Professor Hockertz has been removed from YouTube, as it has been done with many of the videos which criticise vaccination. This exposes that the so-called pandemic was not a health crisis.»

The crisis originated by the secret society elites and their accomplices was not a health crisis. If there had been such a crisis, governments would have set up Health Crisis Cabinets comprising doctors, virologists, scientists and specialised health professionals.

The dense energies attached to the souls of "vaccinated" people continue to vibrate, attracting waves of the same frequency emitted by viruses.

The soul attracts the coronavirus when it vibrates at the same frequency as this virus vibrates. The body DOES NOT attract the coronavirus. It can mutate when it changes its frequency of vibration to a lower frequency range.

The RNA of the virus contains genes, which emit and receive. Then the viruses can receive low frequency waves projected into the atmosphere by millions of people, producing external variants of the Covid.

Everything is energy. And it emits and receives. Fear, hopelessness, uncertainty, suffering caused by company and business closures, lack of work, feeding the family, mortgage payments... as examples, magnetise the brain cells, the thought reinforces what is feared and causes suffering. It lowers the vibrational frequency of the soul, and emits waves that could attract viruses vibrating at the same frequency.

*"The Nuclei of Light are the soul particles that feed each of the billions of cells in the human body, **they are soul**. "They" had the purpose of genetically manipulating the brain cells so that millions upon millions of children of God, the Infinite One, cannot communicate with Him in the Core Being of the soul. "They" know that for this communication with God to exist, the Nucleus of Being of the soul has to be attached to the human brain. And conversely: In order for man to be able to communicate with God, the Infinite, his brain must be united with the Nucleus of Being of his soul.

This is why the vibrations of man's thoughts, words and deeds constantly flow into the soul. Thoughts produce low or high frequency vibrations which the veils of consciousness of the soul register.

"They" know that the veils of consciousness enveloping the soul's Core Self can only register the fields of energies of high or low frequency vibration if they reach them through the cellular ensemble of the human brain.

«They know that only through the human brain can man communicate with God, the Infinite, in the Nucleus of Being of the soul».

This is why they have tried to genetically manipulate the genome of brain cells using synthetic mRNA "vaccines". This experimental gene product contains gene elements produced in the laboratories of the multinational pharmaceutical companies. Thus, their plan to massively "vaccinate" billions of healthy human beings at all costs.

But the dense low-frequency energies registered in the veils of consciousness of man's soul do not disappear because the human body has been "vaccinated". They are active and tend to multiply,

inexorably, if man does not recognise them and surrender them to the Light-Fire of the Infinite, Christ, who will transform them by raising their low frequency into energies vibrating at high frequency.

The fields of dense, low-frequency energies attached to the soul will continue to emit and attract that which corresponds to the frequency at which they vibrate and emit, even though they inject dozens of doses into the bodies in which they have incarnated. Coronaviruses are not attracted or rejected by the body, but by the soul.

«"They", the demons, who vibrate at a low frequency, have hatched this plan because they cannot penetrate the Nucleus of Being of man's soul, which vibrates at the Absolute Frequency, nor can they penetrate any of the very small Nuclei of Light of the billions within the cells of the human body, including those of the brain.

The billions of Nuclei of Light are part of the soul. They are soul. They are the ones who with their *Radiant Light* pass through each cell, binding the cellular assemblies together. This is why, when the person dies, and the soul body leaves the human body, the organic matter disintegrates and corrupts.

These small Nuclei of Light, in communication with the Nucleus of Being of the soul, are within the cells. It is the Nuclei of Light that attract the coronavirus variants when the soul vibrates at the same frequency as the coronavirus.

"The soul is not visible to the human eye as it vibrates at a higher frequency than the physical body; the soul transcends the body by giving its form, for example, to the arms and hands. These material arms and hands make visible the form of the invisible arms and hands of the soul.

When a person has an arm amputated, for example, the arm of the soul is still part of the soul, even though it is not seen by the human eye. It is the "phantom organ" felt by the person whose arm was amputated.

Without the Force radiating from the soul's Core Self, the genes could not "shape" the organs of the human body, just as a computer (PC) cannot do what it is programmed to do without electrical power. When the soul incarnates it enters the body in which its genes, by their frequency of vibration, are the primary factor for this soul to be attracted, and not another soul: *"No two souls are alike"*.

When synthetic messenger RNA is injected into the human body, laboratory-made molecules are introduced into the cells and vibrate at a "strange" frequency. In the medium and long term, these molecules with genetic instructions will cause changes in the cells of the body's organs, so

In Moderna they call this "hacking the software of life". Moderna sees this as an operating system. On their website they call it "Our operating system".

"Since the spring of 2021, since the start of nationwide Covid vaccinations, people have been dying, according to Reitz literally, like flies, which is why millions of deaths have now been recorded worldwide." Reitz differentiated between rapid death within the first fourteen days after vaccination and a permanent increase in the likelihood of premature death. **In the latter case, booster vaccines play an important role.**

"Millions of deaths worldwide are attributable to Covid vaccination. In Germany we have such an obvious excess mortality rate of 22 percent in December and 20 percent in November," says Dr. Reitz. This has not happened since the war. This is what a major newspaper wrote": She expressed astonishment that politicians have never shown any interest in the effects of vaccines and instead tried to find ways to make vaccination compulsory.

"Deaths in Germany. Deaths in England. Deaths in Europe. Deaths all over the world. The fact that nobody puts their finger on it here, from the press, from the government, is the part that really makes your blood boil. We've all seen it before, that a million deaths don't interest us. There are millions dead, there are millions dead. All over the world.

Reitz noted that "very hard data from young people in England" showed that people under the age of 60 have a 100 percent excess mortality rate. *"One hundred percent more likely to die if you get vaccinated than if you don't get vaccinated and then you get some virus, or whatever. In Germany there have been about 12,000 to 13,000 deaths per month from vaccination, with the number increasing from booster vaccines.*

"We had ten percent in October. That was way, way, way too much. And we have institutes that are incredibly well paid, like the Paul Ehrlich Institute and the RKI, which are supposed to be the guardians of our health and should also be able to recognise epidemiological emergencies. Of these 28 objects, in 8 of them the identity of the material with graphene oxide is conclusive due to the high spectral correlation with the standard, and the remaining 21 objects show a very high compatibility with graphene structures, taking into account both their spectra and their optical image. The research remains open and is made available to the scientific community for discussion, replication and optimisation.

AUSTRIA'S CONSTITUTIONAL COURT SHINES AS AN ETHICAL STAR IN EUROPE'S DARK NIGHT.

The Austrian Constitutional Court demanded data from the Austrian Government's Ministry of Health to justify the measures imposed against covid-19. This led Austria and Germany to postpone compulsory vaccination due to "technical problems". It also led the Red Cross to withdraw from the "Austria vaccinates" campaign, abandoning the vaccination ship.

(5 February, 2022).

The Austrian Constitutional Court sent a list of questions on the Covid-19 pandemic to the Ministry of Health at the beginning of February. The background is an ordinance review procedure regarding the Coronavirus measures taken by the government in Vienna. The catalogue of questions can only be described as explosive, due to the political narrative of the government of the Alpine republic. The Constitutional Court sent the Austrian Minister of Health, Wolfgang Mückstein, some questions about the alleged "burden on the health system".

The court wanted to know :

1- Whether the figures for deaths and hospitalisations during the pandemic cover all infected people. The question pointed to the well-known manipulation of data by EU governments on deaths and hospitalisations "with Covid" or "by Covid", which has also been used in Austria. Why was this method of counting chosen?" The judges demanded.

«The Constitutional Court wanted the breakdown of deaths and hospitalisations by Covid, specified by age.

«Was Covid the cause of the hospitalisations?

«Had healthy people been hospitalised unnecessarily, due to a positive test alone?

«Another set of questions was devoted to the effectiveness of the use of so-called protective masks. In the context of the Omicron variant, Austria tightened restrictions in early January, including the use of the FFP2 mask outdoors, if the distance that has long been mandatory could not be maintained.

"The constitutional judges asked the health minister:

«By what factor does wearing an FFP2 mask indoors or outdoors reduce the risk of infection or transmission?"

«The Constitutional Court had calculated the risk of mortality "by Covid" to be 0.15 per cent.

«It demanded to know how the absolute and relative risk reduction of vaccines should be understood.

«The court wanted to know what the absolute risk reduction was after one, two or three injections.

«These questions underlined the judges' doubt about the official propaganda that the vaccines had been 95 per cent effective. What does a specific vaccination effectiveness of, for example, 95 per cent refer to?

«What does absolute and relative risk reduction mean in this context?"

The Ministry of Health should also answer to what extent vaccination reduced the risk of transmission of the virus, since vaccinated people also transmit the virus, however much official propaganda insists on claiming otherwise.

«What is the risk of transmission in a person infected with SARS-CoV-2 with a second vaccination three, six or eight months ago compared to an unvaccinated person whose PCR test was negative 24 hours ago?

«The Court wanted to know the risk of hospitalisation after becoming ill and after vaccination, broken down by age group and number of doses to highlight the side effects of the vaccines, which until now had also been ignored in Austria.

«The Court raised another question about excess mortality in 2020 and 2021: Have there been fewer deaths in 2021 than in the previous year? Was there still excess mortality despite vaccination?

«In short, the Austrian Constitutional Court asked the questions that anyone capable of thinking for themselves would have wanted the rulers to answer. The coronavirus crisis has lasted almost two years, and Austria has distinguished itself by demanding the most extreme measures from the population. It justified the measures on the grounds that they would be the only way to avoid an excessive burden on the health system, and especially on hospitals that cared for "coronavirus patients".

«Dissenting voices and questions about real data had not been taken into consideration. They amounted to inappropriate and reprehensible objections by "Coronavirus deniers" to suffering and death. Politicians had to abide by the advice of "science". Open discussion of critical questions or opposing positions, struggling for a more appropriate policy, was simply forbidden. Therefore, many were astonished to read such relevant questions from the Austrian Constitutional Court almost two years after the start of the massive health crisis.

«Austrian Health Minister Wolfgang Mückstein, 47, had until 18 February to adequately answer the Constitutional Court's 10 questions. Weeks earlier, politicians, media and government officials insisted on the "pandemic of the unvaccinated". They imposed a "confinement for the unvaccinated" on 15 November 2021.

From that day, residents over the age of twelve were only allowed to leave the four walls of their homes to go to work or educational institutions, shop for daily necessities, visit the doctor, or engage in physical sports activities.

According to a media report dated 15 January, Mückenstein was certain that "an early relaxation for the unvaccinated could quickly lead to an uncontrolled spread of the virus and an overloading of health care facilities".

For the judges, however, some questions remained unanswered in this context: By how many percentage points did the confinement to which

the NON-VACCINATED were subjected reduce "the risk of infection of an unvaccinated person"?

«What the unvaccinated in Germany and Austria, persecuted by the rulers, undoubtedly thanked the Austrian Constitutional Court for was that the "compulsory" vaccination with the experimental synthetic mRNA gene product was postponed due to "technical problems".

LIFE SOFTWARE PIRATES, BIOTERRORISTS AND ACCOMPLICES.

In the linked video, Dr. Tal Zaks says that the experimental mRNA vaccine modifies the genetic code (DNA) of people vaccinated with this experimental gene product. Their original genome has been changed by what the scientists have coded.

The individual or subject whose DNA is modified by the mRNA has changed his genome. **He is no longer a creation of God, but a creation of man.** And it could be the subject of a "patent". When Monsanto genetically modified the DNA of an indigenous maize, it patented this variant of the maize seed. And it began to commercialise it, being planted on millions of hectares. The continuous bombardment of mind waves gave rise to external variants of the coronavirus.**

As a projectile they used synthetic mRNA against people, and as a weapon they used the PCR test, which did not detect the virus. **Biochemist and Nobel laureate in chemistry Dr Kary Banks Mullis, inventor of PCR, had already warned that the test «could not detect any infection or disease accurately». Both the US Food and Drug Administration and the Centers for Disease Control and Prevention admitted that PCR was not developed with actual

virus isolates, but with genetic material from a common cold and flu virus: what it detected was not coronavirus.

Therefore, they did not develop the PCR test on real samples, so it did not detect Covid-19, which was not isolated and sequenced by the Centers for Disease Control and Prevention or the World Health Organisation, PCR tests were experimental products licensed by the US Food and Drug Administration. The package inserts stated that PCR tests should not be used to diagnose COVID.

And yet it was the weapon of mass destruction by firing synthetic mRNA projectiles into millions of HEALTHY people who were actually killed and seriously injured in the Covid World War, because the synthetic mRNA acted when it penetrated the body.

The virus worked because what was injected was not a vaccine: A vaccine provides immunity, whereas these experimental gene products required incessant injections, up to four doses in some countries including booster, with billions of synthetic mRNA inoculated. And it was still active.

If the vaccines had produced immunity, a single dose would have sufficed. But these "vaccines" did not eliminate infection, nor did they prevent contagion, nor did they prevent transmission of the virus.

To put it in words familiar to all, this is what happened:

1- They injected into the deltoid muscle the dose of synthetic mRNA with its software, the information designed by the biotech engineer.

The synthetic mRNA delivered to the DNA of the cells its software's "information". 4- But the messenger RNA was also penetrating inside the cells, delivering its 'information' to the DNA of the genes in their nuclei, inducing the production of S proteins, Spike, "foreign" to the organism. Organs became inflamed.

As the cells and organs vibrated at a "foreign" frequency passed by the messenger RNA, their waves were picked up by B lymphocytes, passing the "information" to phagocytic T lymphocytes, which massively attacked the organ "producing viral protein S, Spike. "CDC 2019-Novel Coronavirus , **by** Tim Brown. That there were no *"quantified virus isolates"* of 2019-nCoV , meant that the Centers for Disease Control and Prevention had not isolated that virus, nor had anyone else. Therefore, NO ONE HAD PROVEN THAT THIS VIRUS EXISTED. But it did exist.

That which was created by Darkness and its incarnated instruments on Earth had been ephemeral. The Infinite makes new all that exists within and without the Earth, raising its frequency of vibration to be attracted and absorbed by the Pure Worlds, the Origin, vibrating at the High Frequency of Being. Thus it is being absorbed into the Infinite Universe as it reaches the High Frequency of vibration of the Worlds of Origin from the Finite Universe.

But data from Pfizer's Vaccine **Biodistribution Study** show that the synthetic mRNA and Spike proteins are widely distributed through the bloodstream throughout the body within hours, **causing cardiovascular and neurological damage**, so once the mRNA is distributed through the bloodstream throughout the body, it continues to induce cells to produce S (Spike) proteins. Robert Malone was one of many scientists who warned the FDA about the dangers of protein S (Spike). Robert Malone suggested that autoimmune problems may be related to the free-circulating spike protein that the developers assured would not occur.

Once in circulation, S (Spike) proteins can bind to ACE2 receptors found on blood platelets and cells lining blood vessels, which can cause platelets to clump together, clotting the blood, causing thrombosis, or haemorrhage.

The world's most influential "public health" advocate has apparently come to doubt the technology behind mRNA injections, following their deployment in more than 7.34 billion arms worldwide.

In a little-publicised interview last week with a UK think tank, Microsoft founder Bill Gates made some incredible claims about his most prized "solution" to the pandemic.

"*We didn't have vaccines that block transmission,*" Gates said, contradicting previous interviews in which he claimed that injections significantly block transmission. "*We have vaccines that help you with your health, but they only slightly reduce transmission,*" he added.

[The vast majority of the interview involves Gates demanding totalitarian solutions to bad weather, which he refers to as climate change. The part about COVID injections comes at minute 27.]

Gates is right about the fact that the injections do not block transmission. With record numbers of COVID coming out of Europe, it is obvious that the mRNA injections are doing little, if anything, to stop transmission. Moreover, the impact these injections have in preventing a positive COVID test seems to expire after 6-9 months. Gates was not finished. He added a rather shocking statement to top it off:

"We need a new way to make vaccines". Thus, Gates seems to be washing his hands of his involvement in the global mRNA experiment.

This statement is surprising when his foundation has amassed hundreds of millions of dollars (thanks to pre-IPO access to BioNtech, the maker of the "Pfizer shot") from the sale of these vaccines, in addition to his fierce advocacy of them. In addition, Gates has added billions of dollars in revenue to his personal account during the pandemic.

To make matters worse, Gates endorsed the police state models for COVID "mitigation" currently being implemented by New Zealand and Australia. "At least Australia and New Zealand demonstrated that competent management could keep the death rate very low," he said in the interview. He did not mention that both countries have been blocked by significant parts of 'COVID Mania', with citizens facing massive restrictions on their rights for almost two years. RT-PCR was fraudulently used by governments:

"Hartford Insurance Group announced that mortality increased 32 percent from 2019 and 20 percent from 2020, before vaccination began.

"Lincoln National also reported that death claims were up 13.7 percent year over year, and 54 percent in the fourth quarter compared to 2019.

"Funeral homes are also reporting an increase in burials and cremations in 2021 compared to 2020.

"Similar figures are being reported in other countries. One large German health insurance company reported that its death figures were almost 14 times higher than the number of deaths reported by the German government.

"This helps to understand why the US Centers for Disease Control and Prevention (CDC) and Health and Human Services (HHS) want to hide facts and figures that citizens should know.

"With each passing day it becomes harder and harder for these public agencies to hide the fact that "Covid-19 infection did not kill as many people as the experts claimed, and that the vaccine is killing far more people than the virus".

The official death toll from the pandemic in the US is 875,000. Only 45,000 people died in February [2022]. **The true death toll is over one million, according to The Economist statistics,**

During the interview with the Financial Times (FT) Dr Anthony Fauci, President Joe Biden's chief medical adviser on the pandemic, offered the following optimistic assessment of the pandemic in the US:

"As we move out of the COVID-19 pandemic phase, which we are certainly heading into, decisions will increasingly be made at the local level rather than decided or mandated from the central government.

"There will also be more people making their own decisions about what to do about the virus."

"By not allowing itself to be constrained by the term endemic," he told the Financial Times (FT), the country could soon reach the stage where tracking infections will become unnecessary.

"These comments came as the number of new infections remains at pandemic peaks and the number of deaths is considerable.

"States, counties and individuals are informed that they will be on their own. There is no indication that local or federal agencies will take any action again if another wave of infections begins and health systems are overwhelmed.

Therefore, laboratories cannot certify whether or not SARS.CoV-2 is present in the laboratory culture.*

"A document from the Centers for Disease Control and Prevention (CDC), published on 21 July 2021 by the US Food and Drug Administration (FDA), openly admits that: "The PCR test for Covid-19 was not developed with real samples, but with what appears to be genetic material from a common cold virus. It is antibacterial, antioxidant and anti-inflammatory. It contains flavonoids, phytoestrogens and phytosterols. It protects the body from oxidizing agents such as ultra-violet rays. It contains B group vitamins (B1, B3, B5, B7, B9, B12) as well

as vitamins C, D, E, K and P, and digestive enzymes. It has medicinal properties: it prevents urinary tract infections (cystitis), it can be used as a treatment for anaemia, it strengthens the hair, it favours the elimination of toxins and purifies the organism, improves osteoarthritis, maintains blood sugar levels and it lowers fever.»

«Helping to plant **hemp and esparto crops** in poor soils. Its fibres can be used as raw material for shoe soles and have other multiple applications.»

«Helping to sow seeds of native trees and shrubs, medicinal and wild plants in boundaries, river banks, ravines, hills and mountains.»

«Helping to produce industrial quantities of **compost** from **plant waste to fertilize subsistence gardens, vegetable patches, orchards and farmland.**»

«**Helping to create, in time, URGENTLY, basic food deposits for survival.**»

«Helping to prepare farmland areas for subsistence. This is of vital importance, as the dense energy fields present in the auras of territories, towns, cities and continents announce inexorable discharges. Millions of people will find themselves
