

Alarm in Europe: EU leader calls for scrapping the Nuremberg Code and Human Rights.

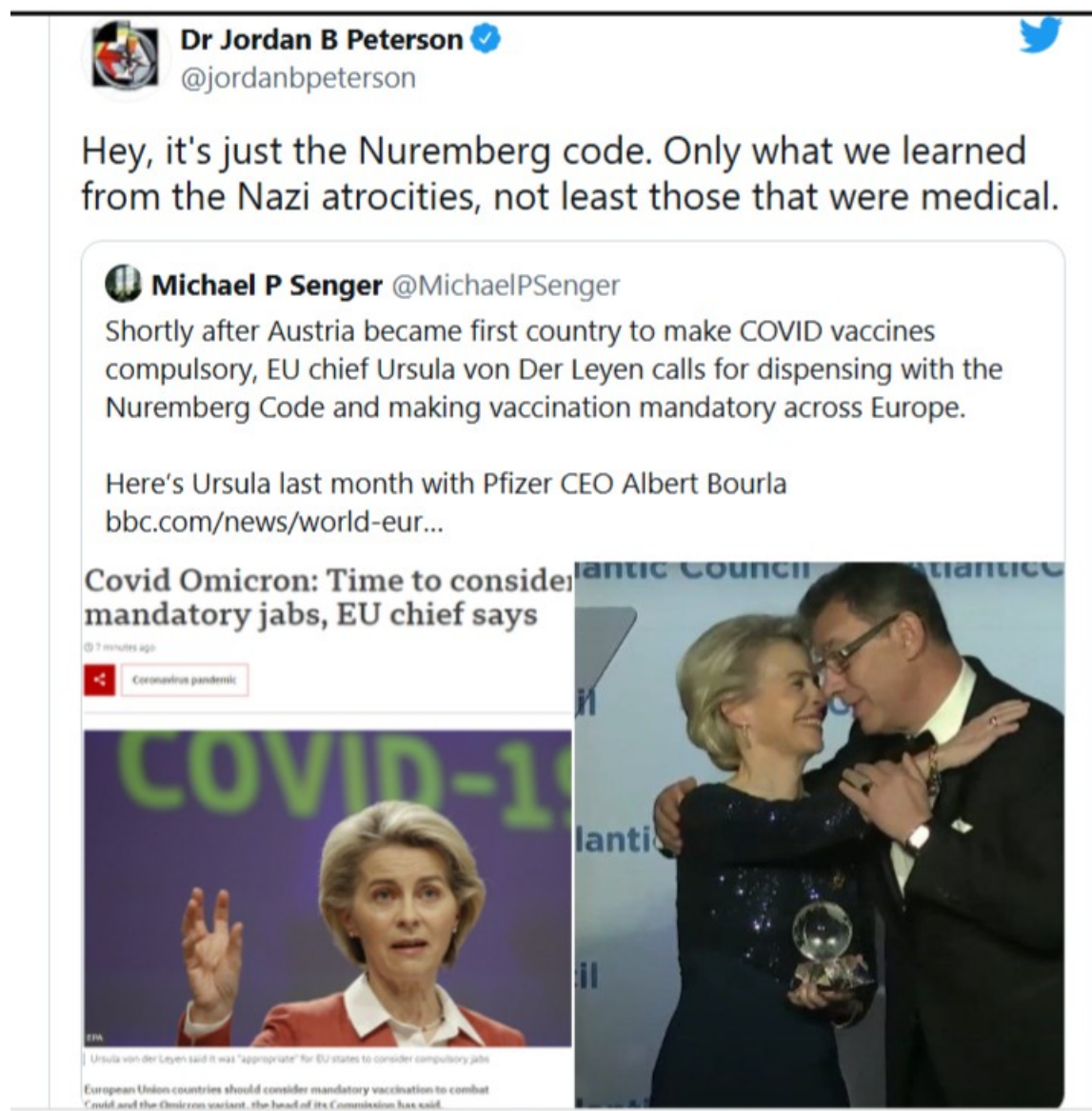
Ursula Van Der Leyen, the top official of the European Union Commission, is reportedly calling for scrapping the Nuremberg Code of Medical Ethics (implemented to prevent the atrocious abuses of human experimentation committed by the Nazis and Japanese during World War II) to force citizens to be vaccinated against Covid-19.

If the move is made, it would be a huge and disastrous step backward for the rights of citizens in the **European Union**, and even outside it. It would set a historic and sad precedent, as this code of **Human Rights** principles has been in force since World War II. This is postponed by the words of **Ursula Van Der Leyen**, the top official of the **European Union Commission**, in an [interview with the BBC](#) in the United Kingdom. The German politician has stated in this medium that she is in favor of eliminating the "old" [Nuremberg Code of Medical Ethics](#) and **requiring people to be vaccinated against Covid-19.**

The protection of the individual would never be the same, **because**, note that this Code contains a series of principles that govern, for example, **experimentation on human beings**, which resulted from the deliberations of **the Nuremberg Trials** at the end of **World War II**. Specifically, **the Code responds to the deliberations and arguments by which the Nazi hierarchy and its doctors were tried and**

convicted for the inhumane treatment they gave to concentration camp prisoners, such as the terrifying medical experiments of **Dr. Josef Mengele, the "Angel of Death."**

It would mean that if Germany (vaccination is already mandatory in Austria) agrees to eliminate it, the rest of the European countries could follow suit, leaving the way open for any vaccine or similar experiment, and citizens could not hold governments accountable for possible future responsibilities... *"Hey, it's 'only' the Nuremberg Code. Just from what we learned from the Nazi atrocities [nothing more and nothing less] from the medical barbarities that were committed,"* **sarcastically notes** renowned professor, lecturer, and podcaster **Dr. Jordan Peterson:**



It's worth remembering that **in Austria** (close to Germany in many ways), people over the age of 12 who are not currently vaccinated are

forced into virtual isolation and confinement, only allowed out for absolutely essential tasks such as grocery shopping or medical appointments. In that interview with the BBC, the EU leader said it was **"understandable and appropriate to consider mandatory vaccine mandates for European citizens,"** especially given the new Omicron variant of Covid-19, which has now been detected in 12 different EU member states.

"How can we encourage and potentially think about mandatory vaccination within the European Union? It needs to be discussed. With a common approach, but it's a discussion that I think needs to be addressed," Van Der Leyen told the BBC. However, the WHO has also strongly encouraged countries not to enact travel bans due to Omicron, reiterating that early data points to the fact that ***"most Omicron cases are not serious."*** Yet, most of the world's governments are not heeding the WHO's guidelines as they are now. (Voices of conspiracy, plot, or global collusion between **multinational chemical companies and governments** are growing louder.)

The Nuremberg Code was enacted in 1947, immediately after the brutal **Second World War**, to prevent many of the egregious human rights abuses enacted by the Nazis and Imperial Japanese during the war. Particularly concerned were the performance of medical procedures on unconsenting subjects. These procedures, often carried out under the command of people like **Dr. Josef Mengele or Hideki Tojo**, were often akin to the worst kinds of torture. Since then, full and proactive ongoing consent has been required. **It would therefore be a brutal violation of the rights acquired 80 years ago by European citizens, and the rest of the world...**
