

INTERRELATIONSHIPS BETWEEN SOUL AND GENES

Everything is energy. The cosmic being-soul registers energy fields while incarnated in a human body. For your understanding, the soul is like the hard drive of a computer, or PC.

There can be energy fields of *High frequency vibration* generated by practising ethical values and carrying in its heart fellow beings and existence of the mineral, plant and animal Kingdoms of Nature. Or he has registered energy fields of Low vibrational frequency generated by actions contrary to the Laws of the Heavens, to the Golden Ethical Rule of Natural Law, caused to his fellow man and to every being and existence of the Kingdoms of Nature.

Energy fields vibrating at High Frequency, and dense energies vibrating at Low Frequency programme their genes.

In the beginning of time there were no carnivorous animals. The big dinosaurs with sharp teeth were herbivores. So they were able to tear the tenderness out of the vegetation. They came to Earth when matter was not so condensed. Could big, heavy dinosaurs chase down small, fast animals to devour them?

What is radiated by the soul of man has been producing changes in the genes of animals for millennia and centuries, both by the good emitted by him, and by the not so good and less bad.

This can be seen in domestic animals that were once wild carnivores. The proverb: "***He who sees an animal sees its owner***" expresses the changes that man's radiation produces in the genes of the domestic animals that live with him.

After the Great Warlike Confrontation of the Peoples of the Earth, the announced Third World War, **will be the Second Coming of Christ in Spirit into the atmosphere of Earth. Then the Golden Age will begin, the establishment of the Kingdom of Peace on the face of the Earth.**

In the course of the future generations that will populate Earth, **the irradiation of the new man, ethical, cosmic, inhabitant of the Kingdom of Peace, will bring about changes in the genes of the animals: "*the lion will be with the***

lamb", as a symbol of what the prophet Isaiah foretold, ***for truly the children will play with the lions' whelps and grow up together.***

The energy fields engraved in the soul vibrate, magnetise and programme the genes of the body in which man incarnated in any century and place on Earth. For example, Europe, 15th century.

The genes emit and receive, and there is a constant interrelationship with the soul. Genes vibrate on the same frequency as the soul that programmes them for as long as the body lives.

When men and women procreate, their genes, programmed by them, are transmitted to the bodies of their children. The children in turn can think, speak and act according to the programmes now inherited from the parents, and the programmes their souls had recorded in previous incarnations. In their present incarnation, children also record in their genes that which corresponds to their own life experiences, which will vibrate at a High or Low frequency. They will in turn pass these on to their descendants, who will pass them on to their descendants from generation to generation.

The soul programmes the genes of the body through the brain. However, parents, or their descendants, can deprogram the energy fields vibrating in their genes, so that the non-positive programmes programmed in the 15th century will also disappear from the genes of their descendants, who emigrated, and in the genes of their descendants who, in the 21st century, live in Africa or in Patagonia.

The Universe is energy in its totality, which vibrates, emits and receives permanently. Everything is communication, and is in communication.

The Father of Heaven, Creator and Ruler of the Infinite, is the All in all. His Son, the Christ of God, the Corregent of the Infinite, is the All in all. Thus, the Father and the Christ are the genes in the third dimensional bodies, and in all processes originating in the genes of these bodies inhabiting the Earth.

To aid your understanding, here is an example: All souls are in communication, for God is the All in all, living in every soul.

The soul that incarnated in a body in the 15th century, and disincarnated years later, left that body. But the genes it programmed are still active in its descendants, emitting and receiving in other bodies, scattered in different countries, centuries later.

However, these genes are still in communication (everything vibrates and emits in the Universe) with the energy fields that remain attached to the soul that recorded them when it incarnated in the 15th century. And they continue to vibrate at high frequency (**positive**, for your understanding) or at low frequency (**non-positive**), when it has reincarnated in another body, for example, in the year 1980 of the 20th century.

In turn, these old energy fields, magnetically attached to the soul, programme the genes of the new body in which the soul has incarnated through the brain. And they continue to give expression to the consciousness of the man living his experiences in the 21st century through his brain, which, in permanent connection with the soul, programmes the genes of the new body.

<< If in his present incarnation the person becomes conscious of:

- 1. A certain dense energy field of Low vibrational frequency (not positive) attached to his soul has manifested itself in thoughts, words and actions he had against a fellow human being.**
- 2. A certain dense energy field of Low frequency of vibration (non-positive) attached to his soul has manifested in thoughts, words and deeds he has had against life forms of the animal and plant Kingdoms.**
- 3. There surfaces in his consciousness the memory of the righteous template of the Golden Ethical Rule of Natural Law: *"Do not do unto others what you would not have them do unto you"*,**
- 4. He reflects on what he has done against a certain fellow human being and against a form of life of the animal and plant kingdoms, and measures these thoughts, words and actions against the just template of the Golden Ethical Rule of Natural Law.**
- 5. He repents from his heart for what he has done and feels in himself the pain, suffering and damage caused to his fellow man and to the life form of a Kingdom of Nature.**
- 6. He apologises heartily to his fellow man, rewards him as far as possible if he has caused him any harm, and rewards the beings of the animal and plant kingdoms which, like him, are sheltered by Mother Earth.**

7. He enters into inner communication with the Infinite, Christ, the Life in him and in all: he puts into His Light that field of dense non-positive energy of Low frequency of vibration,

8. Christ will raise the low frequency of vibration of that energy field until it reaches the High frequency of vibration, Absolute.

9. This dense energy, transformed into positive energy, of High frequency of vibration, Christ will attach to your soul.

And it will come to pass, that all the genes that were programmed by the dense (negative) energy of his soul during his incarnation in the 15th century, passed on by his descendants, and today these genes can be found in people living in the 21st century in Patagonia, or places in Africa, Europe or India, will be released by Christ from the programming induced by the dense energy attached to his soul when he incarnated in the 15th century.

Also the genes of his present body, programmed by his soul, and passed on to his children, will be released from the programming induced by the once dense energy attached to his soul in the 15th century, vibrating now at a High frequency. Christ, the All in all, frees the genes from vibrations foreign to Life.

IMPORTANT: When dense energies of Low vibrational frequency are transformed into positive energies of High vibrational frequency, they leave a **MAGNETIC REMNANT**, characteristic of third dimensional matter. This **MAGNETIC REMNANT** has a certain vibration. It is like a "faded memory" that remains in the thought. "They", the demons, know this: They can then send a mental wave again and again to the thought of the one who no longer has the

dense, negative energy attached to his soul, for it has been transformed into energy of high frequency, positive vibration.

If the one who receives the mental wave with the "image" of the **ALREADY TRANSFORMED** dense energy, **thinks over and over again in that image**, that is, **vibrates and vibrates the received "image"**, then he can gradually **RECREATE** the dense, negative energy, which has already been transformed.

If this happens, then the one who receives the image is WARNED of what "they" intend. SOLUTION: Give the image received to Christ, again and again, without vibrating the image in thought.

When does a soul cut the circles that together form the spiral of successive incarnations of the soul, a spiral that links its experiences from other incarnations and centuries until its incarnation in the 21st century?

As these experiences are expressed in the energy fields attached to this soul - vibrating at High or Low frequency - these energies are also expressed in the programming of the genes of the bodies in which it has incarnated.

When the soul (*as a solar seagull that landed on the shores of the Earth*) investigates itself and with Christ cuts the circles of the spiral cage of its incarnations, it expands its consciousness.

And the soul, now free from the spiral cage of its incarnations, flies from the beaches of the Earth, flying like a solar seagull over the cosmic ocean, living new experiences in the intermediate cosmic stations, **until it reaches the golden Beaches of its solar Cradle, Beyond the Stars.** The solar-soul gull succeeded in reaching the golden Beaches, the Goal of the Origin.
